Dangerous Goods by Air - Acceptance Initial

Three-day in Class, Computer on-line or Virtual Classroom

Purpose

This course helps people to interpret and apply the International Air Transport Association (IATA) Dangerous Goods Regulations (DGR), which applies to both domestic and international air transportation. Full compliance with the IATA DGR and associated Australian legislation, together with an understanding of the underpinning concepts behind these Regulations, will protect shippers, their agents, and operators from unknowingly committing unlawful acts in aviation, thereby ensuring the safety of all those who handle air freight or travel by air.

What you get

You will receive comprehensive training in the theory and practical aspects of shipping dangerous goods by air. The course examines all aspects of the IATA DGR and provides a systematic approach to identifying and preparing hazardous shipments for air transport. There are plenty of follow-up exercises to reinforce the knowledge acquired. You're welcome to bring along material safety data sheets (MSDS) if you wish to ask specific questions.

Course Qualification and Recognition

This course is approved by the ICAO recognized authority:

- The Civil Aviation Safety Authority of Australia (CASA).

A certificate is issued on successful completion of an end-of-course assessment and the qualification is valid for **TWO YEARS**. You must attend a "Refresher" course (one-day) within the two-year period for your qualification to remain valid after this date.

Who Should Attend?

This course is ideal for people involved with the packaging, documentation or control of hazardous materials shipped by air.

Shippers of dangerous goods and all personnel accepting air freight for, or on behalf of, freight forwarders and air operators/airlines have a legal requirement to obtain training appropriate to their job function.

Level of Competency

No previous knowledge or experience with air transport or dangerous goods is required to complete the course.

Availability

Dangerous Goods by Air - Acceptance Refresher

Three-day in Class, Computer on-line or Virtual Classroom

Purpose

This course provides a forum for those people with an existing DG by Air Acceptance level qualification to examine the changes that have occurred to the Regulations since their last course. It gives participants a chance to review the contents of the IATA DGR with a reminder of how the Regulations are applied. Full compliance with the IATA DGR and associated Australian legislation, together with an understanding of the underpinning concepts behind these Regulations, will protect shippers, their agents, and operators from unknowingly committing unlawful acts in aviation, thereby ensuring the safety of all those who handle air freight or travel by air.

What you get

You will receive comprehensive training that covers all aspects of the IATA DGR but focuses on the changes that have occurred over the previous two years. The course gives participants a chance to discuss issues encountered and ask questions to assist with the interpretation and application of the Regulations in the workplace.

Course Qualification and Recognition

This course is approved by the ICAO recognized Competent Authority:

- The Civil Aviation Safety Authority of Australia (CASA).

A certificate is issued on successful completion of an end-of-course questionnaire. A "Refresher" course can only be completed prior to the expiry of an existing qualification. If the Refresher course is completed within the three months window prior to the expiry of the existing qualification, then the participant is recertified for **TWO YEARS** from their original expiry date.

Who Should Attend?

This course is designed for people who already hold a DG by Air Acceptance qualification and wish to renew it for a further two years.

Level of Competency

No previous knowledge or experience with air transport or dangerous goods is required to complete the course.

Availability
